The Law Department, Government of Puducherry has notified a Scheme "Voluntary Internship Scheme for the Law Graduates of the Union Territory of Puducherry" to offer one year internship for the fresh law graduates of the Union Territory of Puducherry who have passed out five years integrated/ three years Degree in Law from Dr. Ambedkar Government Law College, Puducherry with an objective to motivate and enrich their skill in drafting, conveyancing and pleading during their profession. Ten number of eligible fresh law graduates would be covered under the Internship Scheme with a remuneration of Rs.9,000/- per month. **VOLUNTARY INTERNSHIP SCHEME FOR THE LAW  
GRADUATES OF THE UNION TERRITORY OF PUDUCHERRY  
IN THE LAW DEPARTMENT**

The Law Department, Government of Puducherry, proposes to offer Voluntary Internship Scheme for the Law Graduates of the Union territory of Puducherry, who have completed either Five Years Integrated Bachelor Degree in Law or Three years Bachelor Degree in Law from Dr. Ambedkar Government Law College, Puducherry. The purpose of the Scheme is to motivate the Law Graduates and to cultivate and enrich their interest in drafting, pleading, conveyancing and also in legislative drafting during their profession. The Scheme would help the students to enhance their drafting skills and also to secure knowledge about the nature and working of the Law Department. After completion of the internship for a period of one year, the interns would leave the Law Department with profound knowledge and thorough understanding about the functioning of the Law Department. The terms and conditions of the Scheme are as follows:-

1. Every application under this Scheme shall be made as per the prescribed Format annexed herewith and shall be recommended by the Principal of Dr. Ambedkar Government Law College, Puducherry, to the Secretary to Government, Law Department, where the student has pursued his/her studies.
2. The intern shall be a citizen of India.
3. The intern shall be a native by birth or resident of the Union territory of Puducherry for a continuous period of five years and who have pursued LL.B/B.L Degree in Dr. Ambedkar Government Law College, Puducherry.
4. Suitable representation shall be given to SC/ST/Disabled Law Graduates.
5. The internship shall be conducted once in a year.
6. Application shall be accompanied by a brief note not exceeding 250 words indicating applicant's interest in drafting, pleading, conveyancing and legislative drafting.

7. The Law Department, Puducherry, shall reserve the right to select the interns and to revise the Scheme as and when found necessary.
8. The interns may choose drafting, pleading and conveyancing or legislative drafting as their area of training.
9. Duration of the internship period shall be for a period of maximum one year only and the interns will be paid remuneration of ₹ 9,000 per month.
10. Maximum number of interns selected shall be 10 (ten) at any point of time.
11. Interns shall have no access to files or folders in hard or electronic Form which are classified as secret in nature and they shall abide by the directions of the Secretary to Government (Law).
12. Interns shall be available in the Law Department during the working hours and shall be required to sign the daily attendance register.
13. Interns shall be allowed to use the Library of the Law Department only for reference purpose.
14. Interns may be assigned any responsibility relating to study, research or other work in connection with the functioning of the Law Department, and any material prepared by the interns shall be the property of the Law Department.
15. Interns may have to work under the supervision of any officer as decided by the Law Department.
16. Interns shall be required to present a report on the completion of internship tenure of one year and the same shall be evaluated by the Law Department.
17. A Certificate of Internship shall be issued by the Law Department to the inducted interns only on their successful completion of the internship.
18. Internship shall be liable for termination at anytime in the event of misbehavior or misconduct committed by the interns.
