issuance of Certificate / Renewal of Certificate of Practice or  
extension of area of practice as Notary under the Notaries Rules,  
1956".**

through the Drawing & Disbursing Officer, District Court, Judicial Department, Puducherry and other regions respectively.

3. Only after receiving the receipt of payment of the fee mentioned above, the Certificate of Practice will be issued. The Advocate concerned are strictly advised not to commence their practice until till the Certificate of Practice is issued.
