NOTIFICATION

Application is invited from the eligible Advocate practicing in Puducherry, Karaikal, Mahe and Yanam regions for being considered for appointment as a Notary.

A person may make an application for appointment as a Notary (hereinafter called "the applicant"), through the concerned District Judge or the Presiding Officer of the Court or Tribunal, where he practices as an Advocate, in the form of a Memorial, addressed to such officer or authority (hereinafter referred to as the "Competent Authority") of the appropriate Government as that Government may, by notification in the Official Gazette, designate in this behalf and the "Competent Authority", viz., the Under Secretary (Law), Law Department, Puducherry, as required under Rule-3 & 4 of the Notaries Rules, 1956.

The applicant shall submit the application along with self-attested Xerox copies of the originals of the following documents:-

- (i) Matriculation/SSLC Certificate;
- (ii) Higher Secondary Course Certificate;
- (iii) Graduation Certificate;
- (iv) LL.B. Degree Certificate;
- (v) Residence and Nationality Certificate;
- (vi) Enrollment Certificate issued by the concerned Bar Council;
- (vii) Name in the Application Form should be same as that in Enrollment Certificate issued from the Bar Council;
- (viii) Certificate from the Presiding Officer to the effect of practicing in the concerned Bar as on date.

Note: Advocates who have applied on earlier occasions shall submit fresh applications. The previous applications submitted by the Advocates preceding this Notification will not be taken into consideration for appointment of Notaries.

The mode of selection shall be by interview. The last date of submission of application is 05-03-2021. The Notification is available in the Law Department website, viz., law.puducherry.gov.in.
